The company has also gained recognition for significant construction projects in DSI-built irrigation structures, including regulators, tunnels, pump stations, bridges, roads, and steel penstocks. Binatom Electricity's main area of activity is electricity generation, with a total installed capacity of 12.533 MWm (2.070 MWm in Gediz and 10.463 MWm in Emet). 



Rationale for the Rating Score

SETAŞ İnşaat Ticaret ve Sanayi A.Ş. ("Company" or "SETAŞ"), established in 1975, operates in construction and contracting. Since its foundation, the Company has primarily been active in infrastructure construction works for the General Directorate of State Hydraulic Works ("DSİ"), and has also been involved in projects for institutions such as the Ministry of National Defense, Petroleum Pipeline Corporation ("BOTAŞ"), and Eti Mine Works General Directorate. Additionally, Çinigaz Doğalgaz Dağıtım Sanayi ve Ticaret A.Ş. ("Çinigaz"), another company within the same group as SETAŞ, has undertaken natural gas distribution network investments in the Kütahya region. Çinigaz has obtained a distribution license from the Energy Market Regulatory Authority (EPDK) to distribute and sell natural gas in Kütahya and its districts for 30 years starting from 2004. As a result of the Company's history and position in the domestic market, our comparative sector analyses, and examination of the financial/operational risks carried by the company, its long-term rating has been confirmed as (TR) A+ and its short-term rating as (TR) A1.

Outlook

In 2022, the company's revenue decreased by 12.1% compared to the previous year, falling to 73.8 million TL, of which 70 million TL was recognized based on the percentage of completion in accordance with revenue from customer contracts (TFRS 15). In accounting for the revenue and costs of ongoing projects, estimates and assumptions from project budgets are used. In 2022, the company achieved a profit of 24.5 million TL from the sale of tangible fixed assets (2021: 4.9 million TL) and generated a net profit of 98.1 million TL (2021: 84.3 million TL). As of the end of 2022, the company is considered to have positively differentiated itself from the overall industry outlook in terms of financing costs. The company has no foreign currency liabilities as of year-end 2022. Its financial ratios have generally shown a positive trend compared to the previous rating period. Founded in 1975, the company has completed commitment projects worth 4.4 billion TL since its establishment. Its portfolio includes an ongoing infrastructure construction project worth a total of 105 million TL, commissioned by Çinigaz. While there is some concentration in receivables/portfolio, considering the employer institutions, the company's ability to collect receivables is evaluated as strong. The company did not make any new investments in 2022 but continued its existing projects. It operates with minimal reliance on bank loans and maintains a strong equity structure. 75% of the company's total assets (2022: 287.5 million TL) in time deposit accounts at banks. This demonstrates the company's ability to seize and act on opportunities within the sector. Considering all these factors, the outlook has been determined as "Stable." However, recent developments in global trade and financial markets create uncertainty regarding potential economic outcomes. Additionally, rising construction costs pose a risk that short-term uncertainties may negatively impact infrastructure investment decisions in the future. Developments are being closely monitored,
